This letter serves to transmit, on behalf of the Plant City City Commission, one text amendment to the Comprehensive Plan for the City of Plant City in the 4th Cycle 2014. The amendment (PC/CPA 14-04) was adopted by Ordinance No. 7-2016 on February 8, 2016, by the Plant City City Commission.

The amendment (DEO #15-3 ESR) was transmitted to the Florida Department of Economic Opportunity (DEO) in November 2015. DEO reviewed this text amendment and provided their Objections, Recommendations and Comments Report to the City of Plant City, in December 2015. DEO had no objections to text amendment PC/CPA 14-04. No substantive changes were made to the amendment (DEO #15-3 ESR) since last transmitted.

Ordinance No. 7-2016 adopting the amendment is included as an attachment. The amendment becomes effective 31 days after the State Land Planning Agency determines the amendment package is complete and no petition is filed by an affected party.

One hard copy and two electronic copies of the adopted comprehensive text amendment are included in this transmittal to the Department of Economic Opportunity.

The amendment (DEO #15-3 ESR) is being transmitted to the Florida Department of Transportation, Florida Department of Environmental Protection, Tampa Bay Regional Planning Council, Florida Department of State, Hillsborough County Development Services and the Southwest Florida Water Management District concurrently with this transmittal to the Florida Department of Economic Opportunity. #### ORDINANCE NO. 7-2016

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF PLANT CITY ADOPTING AMENDMENTS TO THE COMPREHENSIVE PLAN, ENTITLED "IMAGINE 2040: PLANT CITY COMPREHENSIVE PLAN"; AND PROVIDING FOR AN EFFECTIVE DATE.

Whereas, in accordance with the procedures required by Section 163.3184, Florida Statutes, the City Clerk, with the assistance of the Hillsborough County City-County Planning Commission, caused to be published in The Tampa Tribune, a newspaper of general paid circulation in the municipality and of general interest in the municipality, not one of limited subject matter, pursuant to Chapter 50, Florida Statutes, notice in the form and manner required by Section 163.3184(15)(c), Florida Statutes; and

Whereas, in accordance with said notice, the City Commission held an advertised public hearing on the proposed amendments to the Comprehensive Plan of the City of Plant City, Florida, in the Sadye Gibbs Martin Auditorium of the Nettie Berry Draughon Municipal Building (City Hall), Plant City, Florida, on October 12, 2015, at which time interested parties and citizens had the opportunity to be heard; and

Whereas, immediately following the first public hearing the City Commission caused the transmittal of 3 copies of the complete proposed plan amendments to the Florida Department of Economic Opportunity, and one copy to the Tampa Bay Regional Planning Council, Southwest Florida Water Management District, Florida Department of Transportation, Florida Department of State and Hillsborough County for written comments, there being no other unit of local government or government agency filing a written request with the City Commission for a copy of such plan amendments; and

Whereas, the Florida Department of Economic Opportunity and all other agencies required by law have completed review of the proposed plan amendments, and have provided their written comments to the City Commission; and

Whereas, the Florida Department of Economic Opportunity has no objections to the proposed amendments; and

Whereas, the City Commission has reviewed the written comments submitted to it by the Florida Department of Economic Opportunity, and any other person, agency, or government, and has considered such comments together with public comments presented at the public hearings; and

Whereas, the City Commission hereby finds that the proposed plan amendments is "in compliance" as said term is defined in Section 163.3184(b), Florida Statutes; and

Whereas, the City Commission hereby finds that the elements of the plan, as amended, are related to and consistent with each other; and

Whereas, the City Commission finds that the proposed plan amendments are consistent with the State Comprehensive Plan; now therefore

BE IT ENACTED BY THE CITY COMMISSION OF THE CITY OF PLANT CITY, FLORIDA:

Section 1. The amendments to the comprehensive plan for the City of Plant City, to wit:

PC/CPA 14-04: City of Plant City Comprehensive Plan: Proposed update to the City of Plant City Comprehensive Plan. The proposed updated plan will be titled "Imagine 2040: Plant City Comprehensive Plan." The update includes various proposed changes to data, analysis, plan categories, goals, objectives, policies, maps, definitions, and implementation sections throughout the document,

a copy of which amendments is filed in the office of the City Clerk on the date of enactment of this Ordinance, is approved and adopted.

Section 2. In accordance with Section 163.3184(7), Florida Statutes, the City Clerk, with the assistance of the Hillsborough County City-County Planning Commission, shall transmit three copies of the adopted amendments to the Comprehensive Plan to the Florida Department of Economic Opportunity and a copy of said amendments to any other unit of local government agency in the State that has filed a written request with the City for a copy of such amendments.

Section 3. If any section, sentence, clause, part, or provision of this Ordinance is held to be invalid by a court of competent jurisdiction, the remainder of this ordinance shall not be affected thereby, but shall remain in full force and effect.

Section 4. In the event of a conflict with any other ordinances or parts of ordinances, the

provisions of this ordinance shall control.

Section 5. The effective date of this ordinance shall be the date a final order is issued by

the Department of Economic Opportunity or Administration Commission finding the

amendments in compliance in accordance with Section 163.3184, Florida Statutes, whichever

occurs earlier. No development orders, development permits, or land uses dependent on this

ordinance may be issued or commence before it has become effective. If a final order of

noncompliance is issued by the Administration Commission, this ordinance may nevertheless be

made effective by adoption of a resolution affirming its effective status, a copy of which

resolution shall be sent to the Department of Economic Opportunity, Division of Community

Planning, Plan Processing Team, 2555 Shumard Oak Boulevard, Tallahassee, Florida 32399-

2100.



The Department of Economic Opportunity has completed its review of the proposed comprehensive plan text amendment for the City of Plant City (Amendment 15-3ESR), which was received on November 4, 2015. 

We have reviewed Plant City's proposed comprehensive plan (the Plan) Amendment 15-3 ESR according to the provisions of Chapter 163, Florida Statutes, and our Plan review guidelines. We are providing the following assessment.

Background: Plant City (approximately 24 square miles) is located in northeast Hillsborough County near Polk County. The 2010 population was 34,721 (US Census). Interstate-4, a strategic intermodal system (SIS) facility, extends east to west through the City. US Highway 92/SR 600 (Baker Street) parallels the interstate approximately 1 to 1.5 miles to the south. Other state facilities include SR 39, SR 553, SR 566, and SR 574. Predominant existing land uses include agricultural, residential and vacant/undeveloped. The *Northeast Plant City Area Master Plan* (the *Master Plan*) was completed in 2008 and reflects a land use pattern to minimize additional impacts to I-4. The *Master Plan* recommended roadway improvements to relieve I-4 and to improve connectivity to be funded in part by impact fees.

Proposal: The City is proposing an entire update to their Comprehensive Plan.

#### **Technical Comments:**

- ✓ Overall: Consider eliminating transportation concurrency rather than designating the City as a TCEA.
- ✓ Page 101, First Column, Fourth Paragraph: "This Comprehensive Plan sets out the vision for Plant City and its residents."
- ✓ Page 111, First Column, Second Paragraph: "The existing and future trails and sidepaths are shown...."
- ✓ Page 113, Policy 1.5.3: "Where appropriate and financially-feasible; sidewalk and...."

- ✓ Page 116, Policy 1.11.1: "Ensure that the following are consistent with the *Plant City Comprehensive Plan*, particularly...."
- ✓ Page 125, MBY Table 2: FDOT Policy for LOS Standards for the State Highway System has been changed to state the following: "It is the Department's intent to plan, design and operate the State Highway System at an acceptable level of service for the traveling public. The automobile mode level of service standards for the State Highway System during peak travel hours are "D" in urbanized areas and "C" outside urbanized areas. No specific level of service standards are established for other highway modes (e.g., bus, pedestrian, bicycle). Quality/level of service for these modes is determined on a case by case basis."
- ✓ Page 146, Map 1: Would you want to update this figure to 2015 conditions?
- ✓ Page 152, Map 7: Although not following the precise same alignment as shown in the figure, the Alexander Street Extension from I-4 to Paul Buchman Highway has been constructed.
- ✓ Page 243, GOV Table 1: "The TBRPC has been effective in administerating federal and state programs, along with...."
- ✓ Page 247, Inconsistent Transportation Concurrency Requirements: Again, since Plant City does not wish to utilize transportation concurrency, would it not make sense to eliminate it entirely?
- ✓ Page 249, Policy 1.1.2: "A number of techniques including joint meetings, forums...."
- ✓ Page 255, Goal 1: Why does the goal specifically say "Non-Transportation Standards" but yet Policy 1.1.3 cites Transportation LOS standards?
- ✓ Page 255, Policy 1.1.3: "... Federal and State roads: LOS D for planning purposes, on I-4 (the only FIHS SIS facility) inside the City Limits of Plant City and for all other State roads listed in the Mobility Element."





gency for Pasco, Pinellas, Hillsborough, Taylor and Dixie counties. Damage costs would have to total about \$26 million statewide to reach the threshold for federal disaster assistance.

If that happens, individual counties may qualify for federal aid, provided they meet public thresholds based on population.

"My hope is that the state and federal government see that Pasco has had enough damage" to warrant federal assistance, Pasco Emergency agement Director nette Doying said during a news conference Thursday

In Tampa, where FEMA officials are scheduled to tour water-damaged homes today, city officials have concluded their damage assessment, which will be combined with reports from Hillsborough County, Temple Terrace and Plant City before being submitted to the state Division of Emergency Management, a first step toward seeking FEMA assistance.

Among the casualties listed: city trucks and police cruisers caught in floodwaters, 36 businesses and almost 100 units of public housing with water damage.

But the biggest hit to Tampa is an estimated \$936,000 to repair potholes and road cave-ins caused by saturated soil and a

As of Monday, city maintenance crews had recorded 117 road cave-ins likely caused by weak points in sewer pipes. The city has hired two private utility contractors and shifted staff to create more repair

"We will be at this for months," Mayor Bob Buckhorn said of repair work.

Torrential rains and flooding also have left Tampa roads peppered with potholes. Since Aug 2, the city has tripled the number of maintenance crews working on Tampa streets and repaired 472 potholes.

"This exacerbated this tenfold — water is insidious," Buckhorn said.

Pinellas ty, FEMA officials toured Sherwood Forest RV Park and Caladesi Mobile Home Park, both of which were evacuated because of flooding. The county is still compiling its damage assessment.

Hillsborough County of ficials said they hope to be able to apply to FEMA for assistance. Spokeswoman Michelle Van Dyke said the county is "well into the assessment phase.'

FEMA's assessment team will be in Tampa today visiting flood-damaged private homes. The agency already is providing technical assistance to local governments, and programs that help residents to rehabilitate homes are being made available through the state Division of Emer gency Management, said Chauncia Willis, emergency management coordinator for Tampa.

"They will hit each one of those homes and talk to residents and see what kind of damage they have, Willis said.

#### INTRODUCTION

The Planning Commission will be making a recommendation to the Plant City City Commission on a publicly initiated text amendment to update the *Comprehensive Plan for the City of Plant City,* pursuant to Chapter 163, Part II, Florida Statutes and Chapter 97-351 Laws of Florida, as amended. As Hillsborough County's Local Planning Agency, the Planning Commission has the responsibility to develop and recommend a long-range comprehensive plan to the City of Plant City.

#### **SUMMARY**

The proposed changes to the *Comprehensive Plan for the City of Plant City* now referred to as *Imagine 2040: The Plant City Comprehensive Plan* [located at: <a href="http://www.planhillsborough.org/city-of-plant-city-2040-comprehensive-plan-update/">http://www.planhillsborough.org/city-of-plant-city-2040-comprehensive-plan-update/</a>] were crafted to streamline and improve the overall understanding of the document, address legislative mandates, remove duplication, correct inconsistencies, prioritize staff resources, update project status and encourage future economic opportunities within Plant City. The proposed policy modifications will not negatively affect the level of service standards for potable water, wastewater, transportation, solid waste, stormwater, public schools or recreation and open space within Plant City. Furthermore, the proposed changes will not diminish the overall integrity or character of local neighborhoods and will continue to protect the environmental sensitive areas of Plant City.

#### **BACKGROUND**

Looking ahead, Plant City is projected to increase in population to more than 71,000 by 2040. Where will they live? Where will they work? Where will they play? How will they get there? The *Imagine Hillsborough 2040* public outreach

process was conducted to help guide the update of *The Imagine 2040: Hillsborough Long Range Transportation Plan* and the Comprehensive Plans for Tampa, Temple Terrace, Plant City and Hillsborough County.

Over 3,500 people took part and weighed in on long-range strategies for growth, development, and transportation options for all three municipalities and Hillsborough County. Some of the key results are:

- Over 1,600 participants ranked traffic congestion, job creation, and available bus or rail as top priorities for planning to 2040.
- The "Bustling Metro" land use scenario got the highest rating. "New Corporate Centers" received the second highest, followed by the "Suburban Dream."
- The highest levels of support for job locations were in existing job centers, redevelopment in existing industrial parks, and town centers with a mix of places to live and work, like what is envisioned for Midtown.

Based on the results of this public outreach, the general structure and framework of the *Imagine 2040: The Plant City Comprehensive Plan* was reorganized to include an introduction and four major components that, when combined, represent the City of Plant City as a whole: **PEOPLE, PLACES, NATURAL SPACES** and **GOVERNANCE**. These four components are representative of those fundamental growth management elements required by Chapter 163, Part II, Florida Statues.

In addition to the more general revisions previously noted and while not exhaustive, the following offers a brief overview by element of the major proposed modifications [that were developed in consultation with Plant City Departments and Other Agencies] to the *Comprehensive Plan for the City of Plant City*.

#### **Land Use Element**

- *Projected population, employment and other demographic data to 2040;*
- Updated Existing and Future Land Use Data;
- Updated eleven figures in the element, including those related to Soils, Wetlands, Natural Systems and the protection of Wellfields;
- Developed and added a Countywide Vision Map;

- *No modifications are proposed to the Future Land Use Map;*
- Removed the mixed-use requirement for parcels that have a designation of Light Commercial/Office;
- Noted the allowed development pattern within Midtown will be consistent with the Midtown Redevelopment Vision Plan;
- Added flexibility to the provisions governing build-to-lines and parking within the Mixed Use Gateway;
- Included medical and distribution facilities to the list of eligible uses that may be considered within the I-4 Tech Corridor Overlay, and;
- Allows for the consideration of mitigating low quality wetlands within identified economic competitive sites and the I-4 Tech Corridor Overly.

#### **Mobility Element**

- Changed name from Transportation Element to Mobility Element;
- *Updated base line data to 2010 and projected transportation needs to 2040;*
- Updated nine figures in the element, including those related to Roadway Functional Classifications, Level-of-Service [2010 & 2040], Transportation Network [i.e. Roadways, Bicycle Facilities, Sidewalks and Trails], Mobility Zones and Cost Affordable Plan [2040];
- Updated existing roadway inventory and level-of-service data for Plant City;
- Included information on existing conditions and future plans of the Plant City Municipal Airport, and;
- *Updated bicycle and pedestrian crash data for Plant City.*

#### **Public School Facilities Element:**

- Moved school facilities maps to a general background document used for all of Hillsborough County, and;
- Transferred some meeting and reporting requirements from the Hillsborough County Council of Governments to the each of the jurisdictions and the staff of the Hillsborough County School Board.

#### **Housing Element:**

- *Updated existing and future housing data for Plant City;*
- Projected short term and long term housing needs [13,320 additional units needed by 2040], and;
- Moved non-required housing data to a general background document used for all of Hillsborough County.

#### **Public Facilities Element**

- Updated base line data to 2010 and projected public facility needs to 2025, this includes Potable Water, Wastewater and Solid Waste;
- Changed the term Sanitary Sewer to Wastewater;
- Moved the implementation section into the Capital Improvements Element, and;
- Added language to strengthen the relationship between the Public Facilities and the Capital Improvements Elements.

#### **Environmental Element**

- Changed name from Conservation and Aquifer Recharge Element to Environmental Element;
- Updated the baseline inventory and analysis for environmentally systems present in Plant City, and;
- Updated five figures in the element, including those related to Drainage Basins, Floridan Aquifer, Natural Recharge Areas and lands Susceptible to Groundwater Contamination.

#### **Recreation and Open Space Element**

- Updated park and recreational facility inventory maintained by the Plant City Recreation and Parks Department;
- *Projected park and recreational facility needs to 2040, and;*
- Eliminated duplicate policy direction already contained in the Capital Improvements Element.

#### **Intergovernmental Coordination Element:**

- *Updated inventory of existing Intergovernmental Coordination Mechanisms;*
- Combined the issues and polices related to Annexations and Joint Planning [Infrastructure Service] Areas, and;
- Added policy to support the One Bay Regional Vision, per Ord. 80-2011.

#### **Capital Improvements Element:**

- Merged the Public Facilities Element implementation section into the Capital Improvements Element;
- Added language to strengthen the relationship between the Public Facilities Element and Capital Improvements Element;
- Moved roadway inventory and analysis to the Mobility Element, and;
- Added language to make it clear that Plant City is not responsible for the capital projects of other governmental agencies, such as the Florida Department of Transportation or Hillsborough County School District.

#### **Definitions Section:**

- Added definitions for Category of Public Facilities, Disability, Final and Preliminary Development Orders, and Hotel/Motel;
- Changed the definition of Community Unit to Planned Development, and;
- Revised the term Sanitary Sewer to Wastewater.

Since receiving your last draft of the updated Plant City Comprehensive Plan, staff has received comments [attached] from the Hillsborough County School District and Environmental Protection Commission of Hillsborough County. All of these comments have been addressed and incorporated into the draft plan as of August 14, 2015.



Greetings, Melissa and Shawn:

On behalf of all our Divisions at EPC, let us thank you and your staff for allowing us to work closely with your agency on each of the Comprehensive Plan updates. These latest iterations are well-organized and well-written. You and your staff are to be commended.

We have sent multiple comments and suggestions to your agency over the past 18 months. We appreciate you incorporating the substance of these into the plans. As we review the latest drafts, we have a few more modifications for your consideration.

Each local government has a renewed focus on job creation and attracting specific "target industries" by actively competing against other communities in other parts of the

country. Coordination and cooperation between multiple agencies and organizations is crucial to success. We suggest that a few added sentences placed in two different sections of each Comprehensive Plan might prove valuable.

IDEA #1: ADD TO INTERGOVERNMENTAL COORDINATION SECTION a sentence that would have the local government coordinate with local, regional, state and federal regulatory agencies to encourage these agencies to consider the vision and priorities of the local government and its citizens as stated within the Comprehensive Plan when interpreting their regulations and subsequently exercising their regulatory authority.

#### **EXAMPLE:**

## **Intergovernmental Coordination** (page 236 Plant City Comp Plan)

#### Introduction

The Intergovernmental Coordination Element is intended to show the relationships, principles and guidelines to be used to accomplish the adopted "vision" of the municipality, the preservation and enhancement of its "hometown charm" and character through the coordination of the adopted Plant City Comprehensive Plan with the private sector, non-profit agencies, plans of other units of local governments providing services but not having regulatory authority over the use of land, along with the comprehensive plans of adjacent municipalities, the county, adjacent counties, the regions and the State of Florida. As part of this intergovernmental element Plant City will coordinate with local, regional, state and federal regulatory agencies to encourage these agencies to consider the vision and priorities of the local government and its citizens as stated within this Comprehensive Plan when interpreting their regulations and subsequently exercising their regulatory authority.

IDEA #2: TAKE THE SAME LANGUAGE as is in the current preliminary draft of the Unincorporated County's Plan and incorporate that language into each City's Comprehensive Plan.

In the preliminary draft of the Hillsborough County Comprehensive Plan, within the People, PLACES, Natural Spaces, Governance and Implementation Element (on page 58), there exists the following language:

"LUCC Strategy X: Consideration of mitigating lower quality wetlands within competitive sites that will be developed for target industries shall be evaluated."

We would suggest that the same or similar language be placed within the Comprehensive Plans for each of the Cities. We are not certain if the term "competitive sites" means the same thing within the cities as it does in the County. It may be necessary to customize the terminology for each city. We note that within the current draft of Plant City's Comprehensive Plan Future Land Use Element (page 86) there is somewhat similar language that states:

"LU Policy 6.1.5: Encourage target industries in the I-4 Tech Corridor Overlay through standards and procedures that consider the benefit of job creation in these areas with the potential for mitigating minor impacts to certain wetlands and other natural resources."

## Plant City Comprehensive Plan

#### **Air Division Comments – August 2015**

#### **Future Land Use Element**

Due to the heightened nature of noise issues in recent years, EPC believes it's important to consider that topic as a distinct policy at the most appropriate location in the Plant City Comp Plan. Some references to addressing the adverse impacts of noise were noted in the revised document, most notably the support of the EPC's Noise Pollution Rule (ENV Policy 1.1.5). However, EPC is interested in having a general reference to addressing noise impacts as part of land development and included within the most closely related element.

Therefore, EPC suggests an enhancement to the Natural Environment (Goal 6) section for consideration with a new standalone Policy as follows:

**LU Policy 6.1.6:** New development in and around existing residential <u>eategories</u> <u>neighborhoods</u> shall consider the <u>adverse environmental impacts</u>, <u>specifically</u> noise-related <u>impacts</u> <u>activities</u>, and attempt to minimize <u>their those</u> impacts on residential communities through landscaping and site design (e.g. maximize buffers and setbacks where possible, orientation of potential noise sources, building design, etc.).

The following minor formatting note related to this section is also noted:

- "EPC" was first referenced as an acronym on page 60, but it had not yet been defined. Suggest adding "(EPC)" at the first reference to the agency on page 41.
- Noted that acronyms for EPC, FDEP, EPA etc. were properly identified, but not used throughout document to further minimize length slightly. (not a problem, just a notation)

**Environmental Element** – No comments. The majority of requested edits were made (or paraphrased) as requested.

**Intergovernmental Coordination Element** – Given EPC's jurisdiction in Hillsborough County and their frequent involvement with projects occurring in Plant City, it seems appropriate to include EPC as a formal government "entity" as part of GOV Table 1. The addition of the following row at the appropriate location in the table is recommended:

**Comment 1:** In PSF Objective 1.1 and 1.2 the School Board appears to have been omitted as a participant in the annual meeting due to the Council of Governments (COG) revisions.

**Comment 2:** PSF Policy 2.3.7.c references Objective 2.D, which is no longer included in the revised plan.

**Comment 3:** Page 165, the Future Conditions Maps section references a "Countywide Background Public School Facilities Document", which was not included for review.

**Comment 4:** On page 267 the table titled Hills. County School's 5-Year District Facilities Plan (Cap Table 2) referenced the 2013-17 version that was most recently updated most for 2014-2019. Depending on final adoption timing of this update, the 2015-2020 version may be adopted prior to the final comprehensive plan update adoption hearing.
