# HILLSBOROUGH TRANSPORTATION PLANNING ORGANIZATION BOARD HYBRID MEETING JANUARY 10, 2024 DRAFT MINUTES

#### I. Call to Order, Pledge of Allegiance (Timestamp 0:05:17)

Chair Myers called the meeting to order at 10:00 AM and led the pledge of allegiance. The meeting was held in person and virtually via WebEx.

#### II. Roll Call (Gail Reese, TPO Staff) (Timestamp 0:05:45)

The following members were present: Commissioner Gwen Myers, Mayor Andrew Ross, Commissioner Michael Owen, Commissioner Joshua Wostal, Commissioner Harry Cohen, Commissioner Pat Kemp, Councilmember Lynn Hurtak, Councilmember Alan Clendenin, Councilmember Guido Maniscalco, School Board Member Jessica Vaughn, Charles Klug, Greg Slater, Justin Willits, Planning Commissioner Nigel Joseph

The following members were absent/excused: Mayor Nate Kilton, Joe Lopano

A quorum was met in person.

III. Approval of Minutes (Timestamp 0:06:50) – December 13, 2023

Chair Myers sought a vote to approve the December 13, 2023. Councilmember Maniscalco moved to approve the minutes, seconded by Commissioner Cohen. The voice vote passed unanimously.

IV. Public Comment On Agenda Items (*Timestamp 0:07:04*) (up to 3 minutes per speaker) Additional comments made via <u>Social Media</u> and <u>Email</u> may be requested.

**Rick Fernandez:** Representing the Tampa Heights Civic Association. Went over the history of the pollution/noise wall at Robles Park to be constructed between the park and the interstate. There have been different solutions presented but no resolution. He is bringing it to the TPO Board so it can be addressed.

**Lena Young Green:** Expressed concern for the quality of the air, water, and soil, the preferred barrier at the Robles Park area is living trees. There is the possibility of the creation of a heat island in this area. The neighborhood is asking that the TPO Board support the request and continue having the conversation.

  - Went over project overview
  - Looked at the summary of changes construction acceleration the addition of funds
  - Review of the project timeline
  - Went over outreach for amendment; noted positive new story supporting this amendment

**Recommended Action:** Approve the I-75 from Tampa Bypass Canal and Fowler Amendment to the FY23/24-27/28 TIP.

#### Discussion:

It was noted that the CAC passed this item unanimously.

Councilmember Maniscalco moved to approve the TIP Amendment, seconded by Commissioner Cohen. The roll call vote passed 14 – 0.

- B. 2024 Gulf Coast Safe Streets Summit Interlocal Funding Agreement (Lisa Silva, TPO Staff) (*Timestamp 0:28:48*)
  - Went over the origins of the funds to be transferred
  - Indicated that Hillsborough County stepped up to host this year due to the turnover of staff in this year in Pasco County.
  - Will be held in conjunction with Florida Bicycle Pedestrian Safety Coalition Summit, October 8
     – 9, 2024; location will be at Port Tampa Bay

Recommended Action: Approve the Interlocal Funding Agreement in support of the 2024 Gulf Coast Safe Streets Summit and allow the TPO to receive the funds transfer from Polk TPO.

Councilmember Maniscalco moved to approve the Interlocal Funding Agreement in support of the 2024 Gulf Coast Safe Streets Summit and allow the TPO to receive the funds transfer from Polk TPO, seconded by Commissioner Kemp. The voice vote passed unanimously.

#### VIII. Status Reports

A. **FDOT Freight Analysis** (Brian Hunter, FDOT) (*Timestamp: 0:33:12*)

- Went over the approach for the analysis; provided what type of vehicle is considered a truck, anything over 2 axles
- Four major freight generators: Port Tampa Bay, Tampa International Airport, Sabal Park region (US 301 and I-4), Plant City
- Looked at the distribution footprint and routes chosen
- Noted that the major road links are in the agenda pack and highlighted the ones that go through the Urban Core
- Went over recommendations
  - Truck drivers need to get around in the most efficient way possible
  - Look at I-75, I-4, US 92, US 301, SR 39
  - FDOT is looking at operations improvements to assist in guiding trucks to desired routes

#### Discussion:

It was noted that the port is going to be dramatically increasing their intake; it is going to be extremely important to move the freight effectively and efficiently. Port Tampa Bay discussed the operation increase all along the port. Many roads are being maintained by the port. There is also freight coming into the cruise terminals in addition to additional cruise ships. It was noted that January is Human Trafficking Awareness Month; the port promotes awareness to the truck drivers. There was discussion about getting an expansion of I-275 N back on the TIP and getting it prioritized in addition to looking further at improvements to I-75. It was noted that the PD&E for I-275 has been done. Clarification was asked if truckers are diverting off the highway when there are challenges. They are not getting off as they want to be on the highways. It was brought up that the expansion of rail; the focus of I-275 should be on moving workers. It was asked if it was possible to have a mobility freight study that could be done and to refresh a study on increased rail movement. There are rail points along the port. The challenge is working with CSX; they prefer to do longer hauls. The capability exists, CSX has to agree to take it. It was **noted** that the future of moving freight is not moving it in the Urban Core but moving it around; there is going to have to be east/west movement.

# Councilmember Maniscalco moved to receive the report, seconded by Commissioner Kemp. The voice vote passed unanimously.

# B. Plan Hillsborough 2024 – 2029 Strategic Plan (Melissa Dickens, Planning Commission Staff) (*Timestamp 0:57:27*)

- Went over the background of the plan
- Looked at the project timeline and the timeline
- Reviewed the highlights from the All Staff Survey and the Board Retreat
- Looked at the overview of the draft and the four pillars and goals the numbering does not indicate priority: Integrated and Connected Communities, Partnerships and Community Engagement, Resilient Natural and Built Environment, Technology and Operational Enhancements
  - o Highlighted how the TPO fits into each of the pillars
  - Received comments from the Planning Commission to refine the Integrated and Connected Communities goal

• Went over the next steps and presentation schedule

### Councilmember Maniscalco moved to receive the report, seconded by Councilmember Clendenin. The voice vote passed unanimously.

- C. 2050 Plan Outreach Survey Objectives (Harmoni McGee, TPO Staff) (Timestamp 1:06:00)
  - Went over the name of the campaign and how it fits with the community; Access 2050
  - Going to be meeting people where they are several different ways to complete the survey
     Looked at a high level of the survey
  - Using Metroquest system went over some of the analysis abilities that can be used real-time to make sure a good cross section is obtained
  - Went over the timeline of the survey
  - Noted the incentives being offered for those who take the survey
  - Requested the TPO Board provide goals and objectives as to what a successful outreach campaign would look like
  - Looked at how assistance can be offered

#### Discussion:

It was asked how the prizes would be balanced in fairness. Anyone who takes the survey can win along with people who don't complete the survey, they can contact staff to be entered to win. It was pointed out that with online engagement, large numbers can be deceiving. It was asked if any identifiers would be collected. Yes, demographic information will be requested: zip, age, and race.

Commissioner Owen moved to receive the report, seconded by Planning Commissioner Joseph. The voice vote passed unanimously.

#### Discussion:

It was asked what type of actionable items would be produced from this. Several studies are done but don't go anywhere. Funding a study would come down to the TPO Board approving the UPWP later in the year. If staff begins exploring study possibilities now, actionable items could come out of the discussions before making recommendations. Clarification was asked if this study would be limited to freight only. Yes, that is the request. The study would be to start planning for now and the conversation for the future. The long-term sustainability of trucking with employees, efficiency, etc. may be in question. Looking at alternative ways to move freight is important. This type of study would show where the benefit would impact freight on roads. It was also expressed that CSX be invited to a future meeting to be part of this discussion.

- C. It was asked if the living wall at Robles Park is something that can be discussed. Secretary Gwynn provided background information on this topic. FDOT found a way to put a wall in. Different options were presented before finding funding from the federal government including a living wall, trellis wall, etc. FDOT canvassed the area and asked what type of wall residents would like to use. If a concrete wall is not put in, this is the only part of the stretch that would not be a wall. FDOT would put landscaping in front of the wall.

  - Members asked about the source of the data (Signal 4). FDOT requires the use of Signal 4 but the numbers are not the same as those from the Florida Dept. of Highway Safety and Motor Vehicles. Staff will bring back the differences in methodology to the TAC and update the targets prior to Board action if there are any changes to the data.

  - Members asked about the limits to the project and the need to include the portion of Boyette Rd east of US 301. The project does include this.

# Summary:

Amend two projects in the Transportation Improvement Program:

- 1. Add HART Fixed Guideway FTA Section 5309/5337 (FPN 415172-1) project to the TIP. This project will receive an annual allocation of \$750,000 of FTA Section 5309/5337 funds. The funding will be used to support the rebuilding of five streetcars.
- Update Fowler Ave from 51<sup>st</sup> St to Riverhills Dr (FPN 446270-1) project by changing the eastern termini from Bruce B. Downs Blvd to 51<sup>st</sup> Street and reduce construction funding by \$5,000. This is a resurfacing project that also includes signalization, signage, pavement markings, safety, and drainage improvements.

# **Recommended Action:**

Approve the TIP Amendments to add the HART Fixed Guideway FTA Section 5309/5337 project; and update termini and funding of Fowler Ave from 51<sup>st</sup> St to Riverhills Dr project.

2024 Safety Performance Targets

# Summary:

Under the MAP-21 legislation, the Federal Highway Administration (FHWA) requires state DOTs and MPOs to adopt performance targets for five safety measures, which must be reviewed and updated annually.

Achieving zero traffic deaths is the long-term aspirational goal of the Hillsborough TPO. The FHWA has encouraged MPOs to select realistic targets based on crash data analysis. Using a methodology developed for the *It's Time Hillsborough 2045 Long Range Transportation Plan*, TPO staff use historical crash and safety investment data to forecast performance.

For calendar year 2023, TPO staff is proposing to set safety performance targets as follows:

- Number of Fatalities (2024 year-end total): ≤197
- Number of Fatalities (Five-year rolling average): ≤216
- Number of Motorcycle Fatalities (Five-year rolling average): ≤37.93
- Number of Serious Injuries (Five-year rolling average): ≤941
- Number of Nonmotorized Fatalities and Serious Injuries (Five-year rolling average): ≤240
- Rate of Fatalities per 100 Million Vehicle Miles Traveled (MVMT) (Five-year rolling average): ≤1.49
- Rate of Serious Injuries per 100 MVMT (Five-year rolling average): ≤6.52

These targets represent five-year rolling averages (2020-2024) with a 0.93% crash reduction factor applied. The 0.93% crash reduction factor represents the annual reduction achievable given existing funding, as identified in the *Vision Zero* investment program in the 2045 LRTP.

The TPO Board prioritizes projects for federal and state funding, many of which meet the criteria for safety projects under the Vision Zero program. The 2023-2024 Transportation Improvement Program has numerous funded projects that enhance the safety of facilities on the high-injury network. Upon implementation, these projects will make progress toward improving safety in future years.

# Summary:

The Long-Range Transportation Plan (LRTP) for Hillsborough County is a blueprint for the future, and it conveys the community's transportation vision and priorities. A key part of building the LRTP is to model future traffic volumes and the expected level of congestion on major roads.

One of the most important next steps in the process is to brainstorm and test major projects to determine their performance results. Major projects include any capacity additions, including road widenings, extensions, or elevations, as well as fixed guideway transit projects like water ferries, bus rapid transit (BRT), and rail service.

Over the next three months, each project will be tested in the model and a performance report will be generated. These will also be compared to scores for existing projects from the 2045 plan.

# WHAT IS A PD&E STUDY?

A PD&E study is conducted to meet the requirements of the National Environmental Policy Act (NEPA) and other federal and state requirements. The study is to ensure that the implementation of transportation projects reflect and incorporate the unique engineering and community characteristics of the area. During the study, the FDOT and Hillsborough County will determine the location and conceptual design of feasible "build" alternatives for transportation improvements and analyze each of their social and economic, cultural, natural and physical environmental effects. The "no-build" alternative, which leaves Gibsonton Drive in its present state and provides for only routine maintenance, will remain an option throughout the study.

# **STUDY PURPOSE**

The purpose of the project is to address future roadway capacity issues as well as improve safety conditions on Gibsonton Drive, which is an important east-west connection between I-75 and US 301. The project will also provide improved mobility for pedestrians and bicyclists along Gibsonton Drive. This segment of Gibsonton Drive experiences high crash rates that are higher than the statewide average for similar facilities. Gibsonton Drive is an important freight route that serves as an alternate route to I-75 and has the potential of safely accommodate higher truck volumes. Gibsonton Drive is also a designated Hurricane Evacuation Route.

# **PROJECT DESCRIPTION**

The project traverses the unincorporated census designated place of Riverview and provides access to I-75 from the communities of Riverview, Boyette, Fish Hawk and Lithia. The class of action for this project is a Type 2 Categorical Exclusion. The proposed improvements will include widening Gibsonton Drive, the construction of stormwater management facilities (SMF) and floodplain compensation sites (FPC), various intersection improvements, median modifications, and multimodal facilities (pedestrian, bicycle, and transit accommodation). The No-Build alternative, which involves no new capacity or operational improvements, remains a viable alternative throughout the study process, although it does not accomplish the purpose and need for this project.

# **EXISTING CONDITIONS**

The existing Gibsonton Drive from Fern Hill Drive to US 301 has four travel lanes, two in each direction. The existing right of way is a minimum of 125 feet wide, but varies throughout the corridor from 125 feet to generally 150 feet.

# **TRAFFIC & CRASH DATA**

Crash data along Gibsonton Drive within the project limits was obtained from the FDOT crash records database for the 5-year period including 2018 through 2022. A total of 910 crashes were reported including 280 of them involving injuries and 2 fatalities.

Traffic along Gibsonton Drive in 2022 ranged from an average of 38,400 to 56,600 vehicles per day. Projected traffic by year 2045 is expected to range from 52,500 to nearly 71,000 vehicles per day.

# **PREFERRED ALTERNATIVE**

The preferred alternative is to widen the existing four-lane divided urban arterial from Fern Hill Drive to US 301 to a six-lane divided urban arterial with a 22-foot median. There will be two 11-foot and one 12-foot travel lanes with curb and gutter with a 10-foot wide sidewalk in each direction. Horizontal widening alignments were adjusted to minimize right-of-way requirements, impacts and costs.


Up to 30 feet of additional right-of-way is required along the north side of the roadway between Hagadorn Road and US 301 and up to 7 feet of additional right-of-way is needed on the south side of Gibsonton Drive approaching the US 301 intersection. Additional right-of-way is proposed for one off-site SMF and one off-site FPC site which are located adjacent to Gibsonton Drive.





RE: CRA Request for Additional \$1.5 Million in Funding for Repairs to Historic Tampa Union Station

Dear Chair Henderson and Members of the CRA Board:

We are pleased to provide this letter of support of the request for the CRA to provide an additional \$1.5 million in funding for necessary repairs to historic Tampa Union Station. Thank you for considering this request for this important community asset.

Our all-volunteer nonprofit organization, and its predecessor, includes individuals who advocate for the preservation and expanded use of Tampa Union Station. These efforts, which included raising millions in public and private funds, successfully rescued Tampa Union Station from likely demolition and restored the building for passenger rail use prior to its donation to the City of Tampa in 1998.

Tampa Union Station, located on the CSX main line serving Tampa, currently hosts Amtrak's northbound and southbound *Silver Star* trains as well as Amtrak buses which connect to the state's other New York-Florida train service, the *Silver Meteor*.

Like any building, Tampa Union Station requires periodic repairs. In 2021, Friends of Tampa Union Station first appealed to the CRA Board for funding for key renovations to this building so that it can successfully remain one of Tampa's "front doors" for visitors and residents.

To this end, we recently worked with the City of Tampa Grants Office to secure a \$414,000 State of Florida Special Category Historic Preservation Grant toward the current renovation project. In 2020 and 2021, we raised public and private funds – and successfully managed and completed – the restoration of the historic Baggage Building at Tampa Union Station.

We support the request for an additional \$1.5 million in funds for this Design Build renovation project. The combination of inflation in construction pricing and the identification of pressing repair needs at Tampa Union Station, including termites and water damage, makes the allocation of additional funds necessary.

We respectfully request the CRA and City staff to do the following:

1. **Current Renovation: Proceed with the renovation project as soon as possible.** We encourage the CRA Board and the City staff to hammer out a schedule which everyone can agree on – and move forward as a unified team to avoid more delays and cost increases.

- 2. Future Activation: Draft and issue the Request for Proposals. Tampa Union Station is an underutilized City of Tampa asset with a significant potential for uses beyond its current sole role as an Amtrak station. CRA staff should proceed with drafting the planned Request for Proposals for the operation and management of Tampa Union Station that is complementary to an active train station. This is particularly important considering the expiration of Amtrak's lease in August of this year.
- 3. Passenger Rail Preservation: Work with the Hillsborough TPO, Florida DOT, and other agencies to expand passenger rail use at Tampa Union Station. Historic Tampa Union Station is the second busiest Amtrak station in the State of Florida, and it has the capacity to serve additional trains. In light of Brightline's decision to build another station in Ybor City for its trains, Tampa Union Station has plenty of capacity for new or expanded Amtrak service as well as future commuter rail services.

The volunteers of Friends of Tampa Union Station stand ready to support the CRA and the City of Tampa staff with any and all of these efforts.
