Project Need & Overview

Critical Need and Solution

Critical Need: Additional truck parking along the I-4 Corridor which currently only has 90 public truck parking spaces from Tampa to Daytona Beach.

Solution: Construct the new West Central Florida **I-4 Truck Parking Facility** which includes 120 truck parking spaces and can be expanded to 250 in future phases.

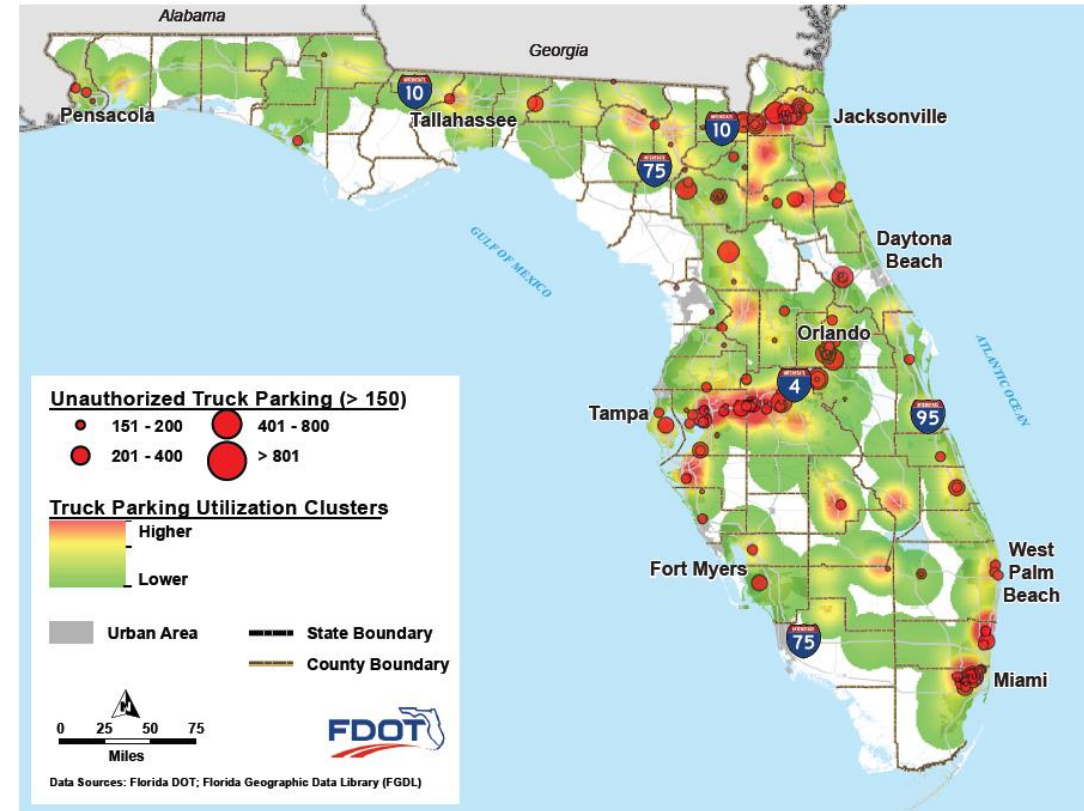


Figure 1: Highly Used and Unauthorized Areas of Concern



Project Overview

- New truck parking facility with ~120 spaces near the Hillsborough-Polk County Line
- Six Electric hookups
- Pedestrian infrastructure to access nearby commercial amenities
- Road ramp improvements
- Connected to FDOT's Truck Parking Availability System to assist commercial vehicle operators in identifying available parking.

- Add \$5.3M in State funds for construction for improvements to adjacent roadways

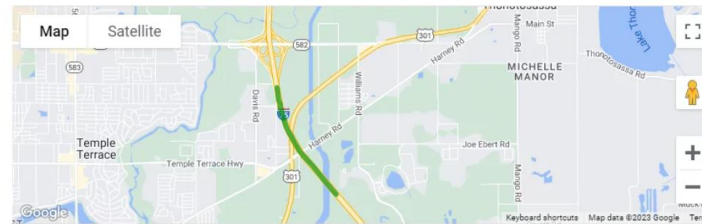

Hillsborough TPO Board to consider Transportation Improvement Program Amendment



Tampa, Florida (December 20, 2023) - The Hillsborough Transportation Planning Organization (TPO) Board will consider a Transportation Improvement Program (TIP) Amendment that will add construction funding and advance the construction phase to FY 2024 for I-75 from south of the Tampa Bypass Canal to south of Fowler Avenue.

I-75 from Tampa Bypass Canal to Fowler Avenue TIP Amendment



The TPO Board will consider amending the Transportation Improvement Program at their January 10, 2024 meeting to add construction funding and move the construction phase to FY 2024 for I-75 from south of Tampa Bypass Canal to south of Fowler Avenue.

This project will add an auxiliary lane in both the southbound and northbound direction of I-75 between the Tampa Bypass Canal and Fowler Avenue in Hillsborough County. The bridges over the Tampa Bypass Canal and Harney Road will also be widened, and the bridge structures over US 301 will be replaced.

Construction is expected to begin in 2024.
